## MASH-UP

The year 2009 brought Soft Touch acknowledgement as an ambitious third sector organisation with the successful award of a large 18-month programme grant through the Youth Sector Development Fund.

The grant has allowed us to develop new models of delivering positive creative activities for young people, particularly focussed on reducing anti-social behaviour and raising aspiration and skills. The MASH-UP programme has worked with over 700 young people aged 13-19 in a 12-month period and facilitated personal development and progression to education and employment for some of the most disadvantaged young people in the city. The work has been centred around the New Parks estate and Soft Touch has developed a welcome presence in contributing to supporting the needs of young people living there.

"We thoroughly back what you're doing; we really think you've helped improve the attitudes and opinions of young people and given them something to do. From what I assess on a weekly basis, reporting of ASB and associated crime have gone down and we're having our best crime recording year for a long, long time on the New Parks estate. A particular success of this programme has been the development of our mobile music and creative activity studio. A Youth Opportunity Fund grant enabled us to purchase and convert a van into a state of the art solar powered studio. We take the mobile studio out onto the streets on Friday and Saturday nights and work with young people where they hang around and give them something positive and worthwhile to do.

As well as delivering activities to young people, our director team have underaken a very high quality business development programme which paired us with a business advisor, Beck Dabscheck from Catch 22. This support has really improved the management and operation of the company, has set us in good stead to thrive in the current political climate and given us tools to become more sustainable in the future through widening our income generation opportunities.

## A few words from our Chair

Given the difficult economic circumstances we are grappling with, it is a testament to the quality of work delivered by Soft Touch staff that we can report another year of solid achievement. The organisation's work is soundly conceived and skillfully executed and that's why people continue to buy our services and support our work. This year we have been fortunate to get some extremely useful business development support through the Youth Sector Development Fund. This has helped us make a number of organisational changes that we believe will help us respond to changing circumstances. As we approach our 25th anniversary we think we are now on a sounder footing that will enable us to continue to offer innovative ways of bringing the rewards of artistic expression to communities in Leicestershire.
